Upcoming Brown Bag, Jan. 29

Marcus Vines will be presenting in our next Brown Bag Workshop on January 29, in TUC 423 from 11:30am-12:30pm. Marcus is in the beginning stages of his dissertation research, which will focus on black masculinity and personal and intimate relationships. He tells us, "Elements of black masculinity can be problematic for the personal and intimate relationships of black men. This is especially



the case in terms of the tension between the contradictory demands of manhood, which propels black men in the direction of multiple sex partners, and the demands of committed relationships and responsible fatherhood, which discour-

ages men from seeking other sexual partners. However contradictory, both sets of demands are firmly rooted in black masculinity. The result is that many men find themselves in a position of constant negotiations with themselves and others about how to be a man that they themselves can respect in the midst of contradictory pressures." This should be a very interesting talk and we hope to see you all there!

Clybourne Park, Feb. 1; Discussions to Follow



Are you going to see Clybourne Park at Cincinnati Playhouse in the Park with the department on February I? Do you know what it is about? Here are some of the details: Clybourne Park is winner of the 2011 Pullitzer Prize and the 2012 Tony Award for best play. It ran on Broadway until September 2012, and we are quite pleased that it is traveling to Cincinnati. The play is comprised of two acts set 50 years apart in the same Chicago house, and deals with themes of race and real estate. In 1959, nervous community members fear housing values will drop when neighbors agree to sell their home to a black family. In 2009, times have changed, and the predominantly black neighborhood is trying to hold its

After the play, please join your fellow sociologists in a **discussion of the play** at the Urban/Race Workshop, on February 6, from 12:30-1:45pm in TUC 405, There will also be a **free, community-wide discussion** about the messages and themes within the play, co-sponsored by Housing Opportunities Made Equal, U.C.'s Kunz Center for Social Research, and Cincinnati Playhouse in the Park. Plus, your very own **Jeffrey Timberlake** will be joining Kathryne Gardette, president of Walnut Hills Redevelopment Foundation, and Timothy Douglas, *Clybourne Park* director, for a panel discussion about the ideas presented in the play and how they manifest themselves today in the Cincinnati region. The community discussion will take place on Thursday, Feb. 6, from 6-8pm at the **United Way Building**, 2400 Reading Road, Cincinnati, 45202.



February Brown Bag: Dating In & Out of the Closet

Mark your calendars for another exciting brown bag to take place on February 26th in TUC 423 from 11:30-12:30pm. Kelli Chapman will be presenting part of her dissertation research titled "Dating In and Out of the Closet: Negotiating Relationships as an LGBT Teen-

ager," which explores lesbian, gay, bisexual and transgender teens' perceptions of dating and sexuality. Kelli tells us, "LGBT youth are of particular interest in the study of sexual choices and behaviors because they possess both a non-normative (non-straight) sexual identity

as well as claim sexual identities at a time in life when sexuality is particularly policed, regulated, and defined as risky and dangerous." This should be another very interesting talk, so please be sure to come and support your fellow graduate student!
