**A&S LANGUAGE REQUIREMENT** 

Approved by SWLC February 2009

The purpose of the foreign language requirement is to insure that students who receive degrees in the College

of Arts & Sciences have had a rich experience in more than one language and familiarity with more than one

culture. The language requirement may be fulfilled in 15-18 credit hours, depending on placement, or by

demonstrating proficiency through testing, as described below.

Although students take language courses in various departments, the fulfillment of the requirement is

certified ONLY by the student's college.

**LANGUAGES** 

The A&S language requirement may be fulfilled by courses in these languages:

Arabic, American Sign Language, Chinese, French, German, Greek, modern Hebrew, Italian, Japanese,

Korean (through the Consortium with Northern Kentucky University), Latin, Portuguese, Russian, Spanish,

Swahili. The Celtic languages (Modern Irish, Scots Gaelic, and Welsh) are offered intermittently through

the School.

Students should consult the SWLC website to verify that the appropriate level of study will be offered in the

time period required.

PLACEMENT: NO PRIOR LANGUAGE STUDY

Students who matriculate in the College of Arts and Sciences with only **one year or no** previous foreign language training, or who wish to commence study in a language in which they have had no former training, must complete all three terms of Basic Language instruction or all six terms of Extended Basic Language instruction in a single foreign language. This requirement is fulfilled by the completion with a passing grade

in the final course of either of these course sequences:

**Three-Quarter Sequence:** 5 credits each, 15 total of

Basic Language 101-102-103 or Latin 104-105-106

OR

**Six-Quarter Sequence:** 3 credits each, 18 total of

Extended Basic Language 111-112-113-114-115-116 or Latin 101-102-103-211-212-213).

NB: Students must receive at least a C- in order to continue from one course to another in any language

sequence.

#### PLACEMENT: TWO YEARS OF HIGH SCHOOL LANGUAGE

Students who wish to continue with study of a language in which they have had **two** years of high school or other training will be placed automatically into the second course in the Basic Language sequence (102) by the Admissions Office. They fulfill the requirement with a passing grade in Basic Language 102 and 103 (total 10 credits). If scheduling does not permit the 5-credit course, the requirement can be met with Extended Basic Language 113-114-115-116 (total 12 credits) or Latin 103-211-212-213 (total 12 credits). For placement in Latin, consult the Latin Language Coordinator.

NB: Automatic placements by the Admissions Office are subject to review, approval and reassignment by the appropriate Language Coordinators. Students may consult with Coordinators for a review of their placement.

### PLACEMENT: THREE or FOUR YEARS of HIGH SCHOOL LANGUAGE

Students who wish to continue with study of a language in which they have had **three or four** years of high school or other training will be placed automatically into the third course in the three-quarter sequence (103) by the Admissions Office. These students fulfill the requirement with a passing grade in that course. If scheduling does not permit the 5-credit course, the requirement can be met with Extended Basic 115-116 (total 6 credits). For placement in Latin, consult the Latin Language Coordinator.

NB: Automatic placements by the Admissions Office are subject to review, approval and reassignment by the appropriate Language Coordinators. Students may consult with Coordinators for a review of their placement.

## TESTING OUT OF THE LANGUAGE REQUIREMENT

- 1. Students with **extensive prior experience** in French, German or Spanish may fulfill the requirement with a score of 500 on the appropriate Language Placement Test; detailed instructions for completing this process are found in the document "Taking UC's Foreign Language Placement Test (FLPT) for Waiver of Spanish, French or German Language Requirement." The procedures outlined must be followed carefully.
- 2. For all other languages, the waiver is based upon certification from the appropriate Language Coordinator for all other languages. This certification is contingent upon performance in an oral interview as well as a written test. Students should contact the SWLC office for more information. NB: Students receive no credit by placing out of the language requirement through this certification.

#### ADVANCED PLACEMENT STUDENTS

Students who have participated in the Advanced Placement Program in high school receive college credit, based on their scores, without further validation. The credit is allocated according to college guidelines. (<a href="http://www.admissions.uc.edu/documents/AP-Key\_04-05.pdf">http://www.admissions.uc.edu/documents/AP-Key\_04-05.pdf</a>) These students should see the Undergraduate Director for guidance in course selection.

# WAIVER OF THE LANGUAGE REQUIREMENT

Students who for reasons of a disability are not able to complete the language requirement may petition the College for a waiver of the requirement. In granting such a waiver, the College will normally require that a student complete an alternative course of study of a specific non-English-speaking culture.

Native speakers of languages NOT taught at UC may apply to the college of Arts & Sciences for a waiver. The requirement will be waived for students who have had schooling in the language through the equivalent of the eighth grade.

Heritage speakers who have learned a language at home but have received little or no formal instruction in that language may also apply to the college of Arts & Sciences for a waiver. The college will give the student a checklist to be completed by a native speaker on the UC Faculty who is willing to evaluate speaking, listening, reading and writing skills. The Faculty evaluator will complete the checklist and mail it to the School of World Languages and Cultures (ML 0381) for a recommendation. See next page for Checklist.

## **A&S CHECKLIST for EVALUATING LANGUAGE FLUENCY of HERITAGE SPEAKERS**

**Heritage speakers** are those who learned the language at home but received little or no formal instruction in that language.

**Language fluency** encompasses four areas: speaking, listening, reading and writing, ranging in that order from the simplest to the most complex linguistic tasks.

**Evaluation** of language fluency may be accomplished in several different ways, but in order to reduce the amount of time necessary to assess the skills of an individual speaker, the following checklist should allow a fair examination in about 20 minutes.
